In your contract:

Article XI-Section C. Family and Medical Leave Act (FMLA) - paragraph 5

"An employee requesting a FMLA leave must provide the Assistant Superintendent of Human Resources at least thirty (30) days advance notice of when the leave is to begin. If such notice is not feasible, then notice is to be provided as soon as possible."

--See the full language in your contract on pages 24, 25 and 26

We have received feedback from the district indicating that they are often not given the required notification. The sooner you let them know, the easier the process will be for everyone involved. # Weingarten Rights

As a union member, you have a right to have union representation at any interview or meeting that could lead to disciplinary action against you. Should you be called to see administration for a meeting, you should ask a simple question: "Could this meeting lead to possible disciplinary action against me?" If the answer is "yes", you have a right to have a union representative at this meeting. It is your responsibility to make this request. Once the request is made, the meeting should be delayed until you are able to meet with your union representative.
